This course aims at introducing participants into recent research on the territorial organisation of the, mostly democratic, state.

Students are expected to:

- attend sessions regularly

- hand in one research paper of about 15 pages or two research essays of about 7 to 8 pages in length on 10 September 2017 at the latest (late assignments will be penalized, unless prior arrangements are made!). You are free to hand in individual research papers or group research papers.

Since most reading assignments are in English, this will be the general classroom language as well. Participants therefore must know enough English to be able to participate actively. Perfection is not required – you just need to understand and make yourself understood.
